Praying for justice as the “investigators” are investigated



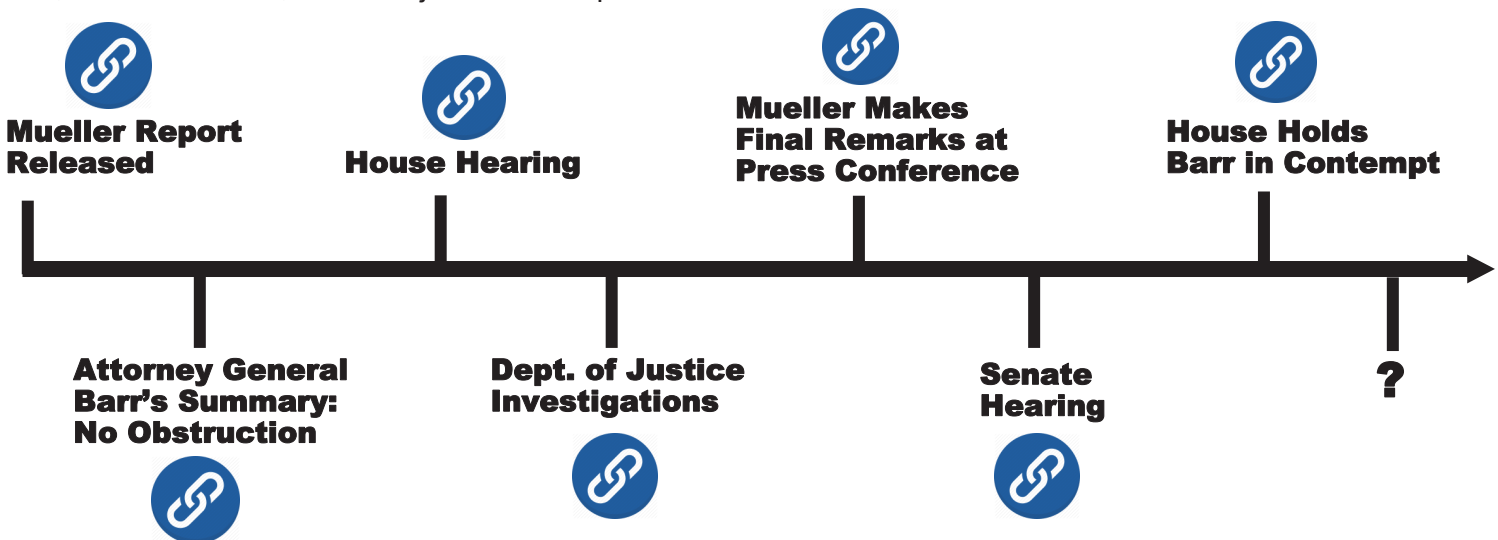

Timeline in the Pursuit of Justice

The Mueller report was delivered to the Justice Department on March 22, where it was summarized for the public in a four-page brief. It outlined the findings—or lack of any findings—of obstruction or collusion with Russian agents by President Trump. What happened next was shocking. Instead of relief from no findings of foul play, the conclusive findings failed to appease the partisans in Congress or the liberal media. It set off a frenzy of continued hearings and plans to disregard the result of the 2-year investigation, and attempted to find a way—some way—to charge the President. Below is the timeline from the Mueller Report to today. Click into each link for background information. 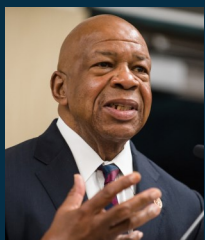
Pray that each of these leaders who are relentlessly pursuing charges—any charges—against the President for partisan reasons would be thwarted.
