## What is Durham looking for?

Horowitz's Inspector General report issued last year was narrow in scope, but the upcoming Durham report has looked for wrongdoing throughout the FBI investigation of President Trump's campaign. John Durham is a U.S. Attorney serving as a DOJ-appointed federal prosecutor. **This is a criminal probe. This report will result in charges**. While the lack of leaks has given us little to anticipate, we do know a few things:

- The probe is focused on the actions of the **former Obama Administration senior officials** who targeted President Trump and his campaign team.
- According to reporter <u>Catherine Herridge of CBS</u>, the timeframe that appears to have the largest paper trail footprint is January—May 2017, Indicating that the **Mueller** investigation and those involved may be the largest focus.
- Durham's investigation was upgraded to a **criminal inquiry** in October 2019; as a result Durham has the authority to bring forward indictments.
- Durham's investigation expanded to include the **Pentagon's Office of Net Assessment** which contracted **Stephen Halper** as an informant. It is alleged that Halper targeted **Carter Page, George Papadopolous,** and **General Flynn**.
- One issue we know is being investigated is whether or not a crime was committed by former **FBI lawyer Kevin Clinesmith** who altered a document for a FISA renewal on Carter Page.
- Attorney General William Barr and U.S. Attorney John Durham have traveled to England and Italy to interview senior foreign intelligence officials.
- The President has given AG Barr authority to declassify documents as needed for the inquiry.
- Durham's report is expected to be released late spring or early summer of 2020.

In response to the IG Report from Horowitz, U.S. Attorney John Durham, issued this <u>statement</u>: "Based on the evidence collected to date, and while our investigation is ongoing...we advised the Inspector General that we do not agree with some of the report's conclusions as to predication [what the operation Crossfire Hurricane was based on] and how the FBI case was opened."
