Protecting the vote preserves the Republic

Voter fraud and dirty tricks are not just a recent political problem. There are many examples of elections through the years that were "stolen" by a shady and greedy candidate.

The Johnson Amendment resulted from efforts to squelch the influence of conservative organizations in the 1954 primary election then-Senator Lyndon Johnson faced against Dudley Dougherty. (In 1948, Johnson was first elected Senator through <u>ballot fraud</u>.) Johnson hoped to limit the influence of tax-exempt 501c3 organizations who favored his opponent in his election. The Johnson Amendment has almost completely silenced pastors and churches from speaking about politics. It has recently been weakened but not completely repealed.

Election tampering is still a problem and may be more widespread, more brazen, and more creative. There are now multiple avenues for voter fraud. Unauthorized (illegal or dead) voters. Ballot and voting machine rigging. Ballot harvesting. Misinformation and false voting guides. Search engine manipulation. Social media suppression. Physical intimidation at polls. How can we be sure that our election is fair and free?

The stakes are high in 2020. In fact, the COVID-19 situation has given the perfect cover to fundamentally change our voting processes. <u>Eric Holder</u>, Obama administration Attorney General, who has been working behind the scenes in redistricting, said, "Coronavirus gives us an opportunity to revamp our electoral system." Even if we agreed that it needs to be revamped, how is the critical question.

Our prayer and action can help strategically affect the plans of the enemy to twist truth and "steal, kill and destroy." Familiarize yourself with the vulnerabilities, get involved in the process, and pray.

7 methods of election tampering that need your prayer



1. Unauthorized Voting

CBN reports that "America has 3.5 million more voters than eligible adult citizens." The requirement for showing identification at polling locations is different from locale to locale. With illegal aliens now permitted to get a driver's license in many states, even voter ID by drivers license is not fool-

proof. <u>Project Veritas</u> shared an undercover video of voters and poll workers in New Hampshire allowing out of state voters with no ID and no residency to vote immediately. This is still happening in 2020 even after exposure in the 2016 election. According to **Tom Fitton** from <u>Judicial Watch</u> (above), 11 counties in California have registration rates exceeding the number of eligible voting-age citizens. In Los Angeles County alone, 1 out of every 5 registrations belongs to someone who is either dead or has moved. Judicial Watch won a lawsuit to clean up the rolls in California, but the jury is out to see whether the state will comply with the National Voter Registration Act (NRVA). **Pray Proverbs 6:16-19.**

2. Ballot and Machine Rigging

It goes without saying that a vote is only good if it is protect- 4. Misinformation and Fraudulent Voter Guides ed and counted. If you vote for Candidate A and your vote is switched behind the scenes for Candidate B, you will never know, and your vote is stolen. Since the dawn of electronic voting machines and even "vote by mobile phone," the opportunities for hacking, fraud, and rigging have increased. At a "Black Hat" convention, security experts demonstrated a security flaw that allowed casting multiple votes. Even an 11-year old was able to hack the system in minutes.

There have been many reports of voters noticing that a candidate other than the one they cast the ballot for showed up on the screen or on their receipt. Coincidence? There are multiple points of vulnerability in the electronic election process which make it at risk for inappropriate access or tampering:

- Voter registration systems •
- Voter registration database storage
- Voter records at polling places
- Voting machines .
- Vote tabulation

All of these points of vulnerability have the same thing in common-potential exposure to the internet for tampering and manipulation. Varying or lax security protocols and human error in following them is also a concern for protecting the election process. Pray Proverbs 12:22.

3. Ballot Harvesting



Third party collection of paper votes which are then submitted to polling officials is supposed to streamline the process and help increase voter turnout. Consider the potential harm when votes are entrusted to activists and political

operatives. Despite the many concerns raised, this use of ballot harvesting has increased. Democrats, usually favor ballot harvesting, for the purpose of inclusion; laws have been quietly passed in heavily Democratic states such as California, legalizing what some call "the new way to steal an election." It's easy to call and order ballots on behalf of someone, steal if from the mailbox, complete it, and illegally vote on their behalf. Ballot harvesting has become big business. Ballots delivered on election day and provide another means of "ballot stuffing" by producing what is needed according to the polls to put their candidate over the top. New mail-in ballot processes also pose potential problems. Pray Leviticus 19:11.

Texas churchgoers who were diligently seeking to vote biblical values by consulting a popular voting guide were surprised to find out that the voter guide their church was distributing was in fact a fake. "Bait and Switch" voter guides are a new and creative way to deceive people about the candidates' positions on important issues for valuesoriented voters. We have come to expect outright lying in political advertising. But, there have also been robocalls and mailings that claim that a voting day or location has been changed in order to confuse and thwart the vote of potential voters of opposing candidates. Pray Proverbs 19:9.

5. Search Engine Manipulation



Psychologist and author Dr. Robert Epstein (left) testified before Congress to share his findings and concerns about the influence that search engines can have on elections, as seen in the 2016 election. According to the research of his team at the American Institute of Research and Technology, they discovered at least three ways that a

search engine (Google, YouTube, Facebook and others) might swing undecided voters, without any knowledge of the one being swayed.

A. Blacklisting. Google has at least ten different blacklists-they can block access to websites without users being aware.

B. Search engine demoting and promoting. Google wields so much power in the ranking of search results that actually amounts to censorship. In a critical time like an election, these rankings can be very effective in diverting voter interest and suppressing other candidates' messages. A secret company called The Groundwork was created with Eric Schmidt, head of Google, and Obama officials with the express purpose of electing Hillary Clinton. Schmidt even wrote Clinton, offering to supervise their tech operations for the Clinton campaign. This was discovered in the recently published Clinton emails.

C. Surveillance. With so many organizations and companies using Google services for documents and other functions, the Google servers have become a treasure trove of information for those who want to spy on opponents.

Even left-leaning media outlets like WIRED reported concern for the massive control that Google can exert in the election process with the headline, "Google's Search Algorithm Could Steal the Presidency." That says it all. Pray <u>2 Peter 2:19</u>.

6. Social Media Suppression and Control

If search engine manipulation isn't enough to shift focus onto Google's chosen candidates, social media will further censor the message of opponents. Researchers at **Face**-



book exposed 61 million users to a "get out the vote" message during the 2010 congressional races and found they were easily able to generate 340,000 extra votes across the board. This test opened the door for Facebook to begin their intervention, all while claiming it is nothing more than organic algorithms. Algorithms reflect the ideals and values of those

writing them, and as we have seen with <u>whistleblower sto-</u> ries coming out of Project Veritas, there has been much intentional intervention in the algorithms on Facebook. Facebook can tailor the group that receives a message—sending specific messaging for an issue or candidate to a specific audience. <u>Harvard Law professor Jona-</u> <u>than Zittrain</u> calls it "<u>digital gerrymandering</u>." Pray James 3:16.

7. Strong-arm Certification of an Election.

We saw this happen in several races in 2018. Polls closed, votes were in, and apparent winners were declared. Then, mysteriously, additional votes were "found," and more "found," until the opponent overcame the margin of votes needed to claim victory. At that point the election was immediately certified. Suspicious wins with these characteristics took place in New Mexico, <u>Texas</u>, California, and <u>North</u> <u>Carolina</u> to name a few. Who can forget the video of the

5 Action Steps You Can Take to Help Protect the Vote

Maintaining voting integrity is not a partisan issue. All Americans should want to protect the voting process for accurate results and to guarantee free and fair elections in our nation. By getting involved in even just one of the five concrete action steps listed below, you are helping to "true the vote." (Even as this new climate of coronavirus changes to our processes, you can participate.)

Get involved as a **Election Observer** or **Poll Watcher**. The 10th Amendment gives authority of elections to the states—so roles and processes will vary by states. This volunteer position of an election observer can be on alert for fraud or problems not only at the polls on election day, but also at voter registration locations, central count locations, and mail-in receiving and count locations. The opportunity to participate as an observer can start well before election day. Contact your local election office to get started. <u>TrueTheVote.org</u> is a great resource for education on participation.

Participate in or host a **Voter Registration Drive**. By legally and lawfully registering eligible voters to vote, you are helping fill the pipeline with legal voters who can help offset voter fraud and strengthen the registration process. By being a part of the voter registration process, you are strengthening the integrity of voting in your community. Contact your local election office to find out how you can take part.

Report any fraudulent activity you see before election day, or on election day. From sign removal, to electioneering violations, to suspected fraud, speak up and report it! The only way to maintain lawful activity is to help enforce the laws. Find out what your state electioneering laws permit and contact your local election office with any violations.

Get involved with your local and state legislators to **advocate for reform of election laws**, to provide solutions for strengthening election integrity, such as Voter ID laws and maintaining the electoral college. You can join an effort in progress, or if you do not see an effort underway, spearhead it yourself. If you feel led by God to do something like this, He will provide the resources and gifting you need to follow His direction.

Prayer walk election offices, polling places, and other critical election locations. Your prayer walking can begin anytime, and can include praying for officials and candidates by name (see your state and local websites for names of those to pray for). Pray Scripture such as Mt 6:10, "Your kingdom come...on earth as it is in heaven" and others verses that declare God's ultimate purposes over our nation. Join with other intercessors to create a "boots on the ground" prayer walking campaign. Intercessors for America has a <u>prayer walking guide</u> you may find helpful.
