Is justice about to be served?

[Documents released](#) on May 13, 2020 indicate that **General Flynn** was being surveilled by the government he served and that a number of high-ranking officials from the Obama administration—including then-Vice President Joe Biden—requested information concerning General Flynn’s activities while serving as a General in the U.S. Army. These high-ranking officials’ names just became public in a document revealing the names of those who requested Flynn’s identity to be “[unmasked](#).” “Unmasking” is a legal request made by intelligence officials to acquire the real identity of a person who was under blind surveillance. The timing of these requests should be noted—they are after the 2016 election in the waning hours of the **Obama administration**. The motive and use of this information is not completely known except that these reports were used by U.S. intelligence agencies to initiate the conversation at the White House where Flynn, was entrapped to lie, and was denied access to an attorney. We also know that these intelligence reports were also leaked to the Washington Post starting the public campaign where General Flynn’s reputation was tarnished.

The focus in all of this has been the removal of **President Donald Trump**. 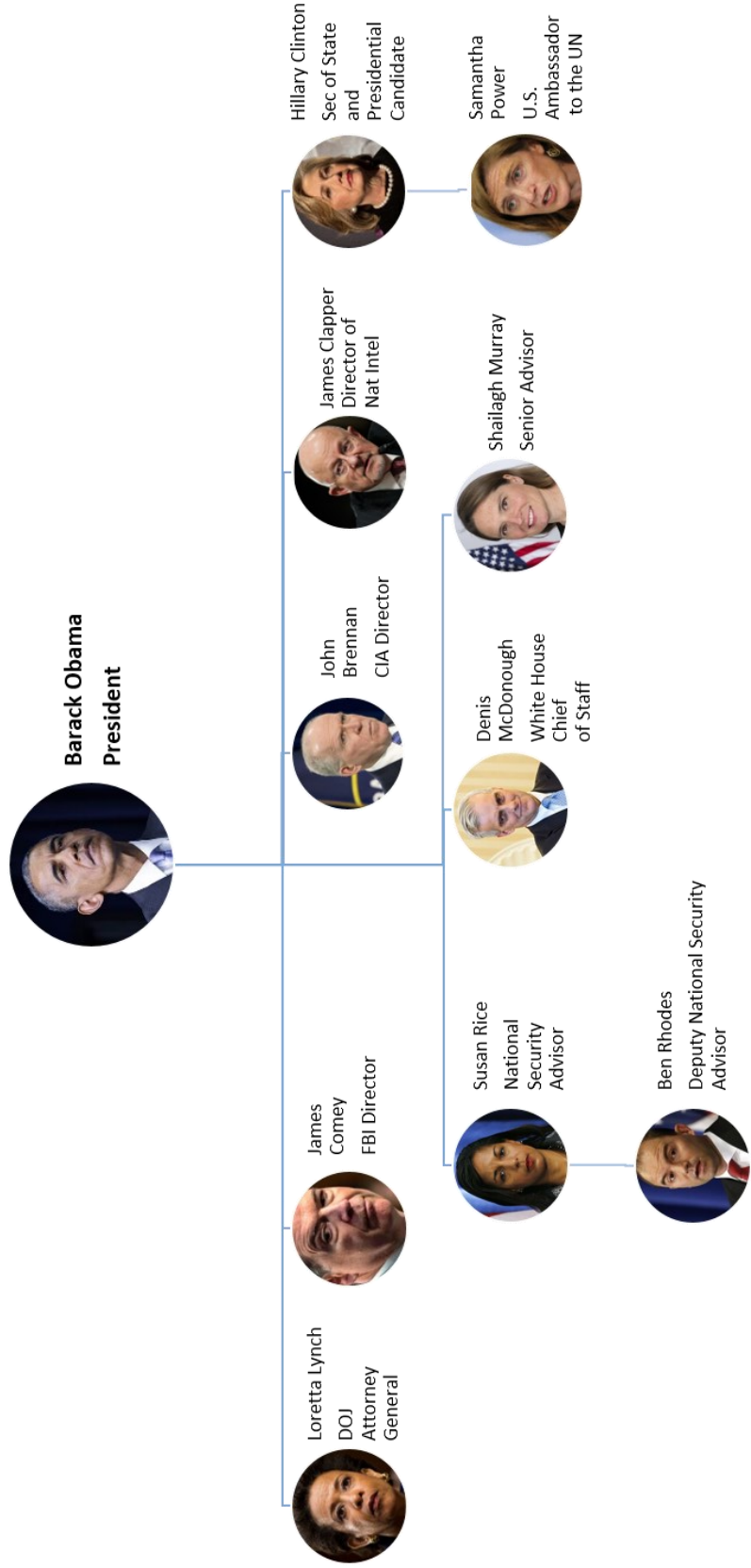

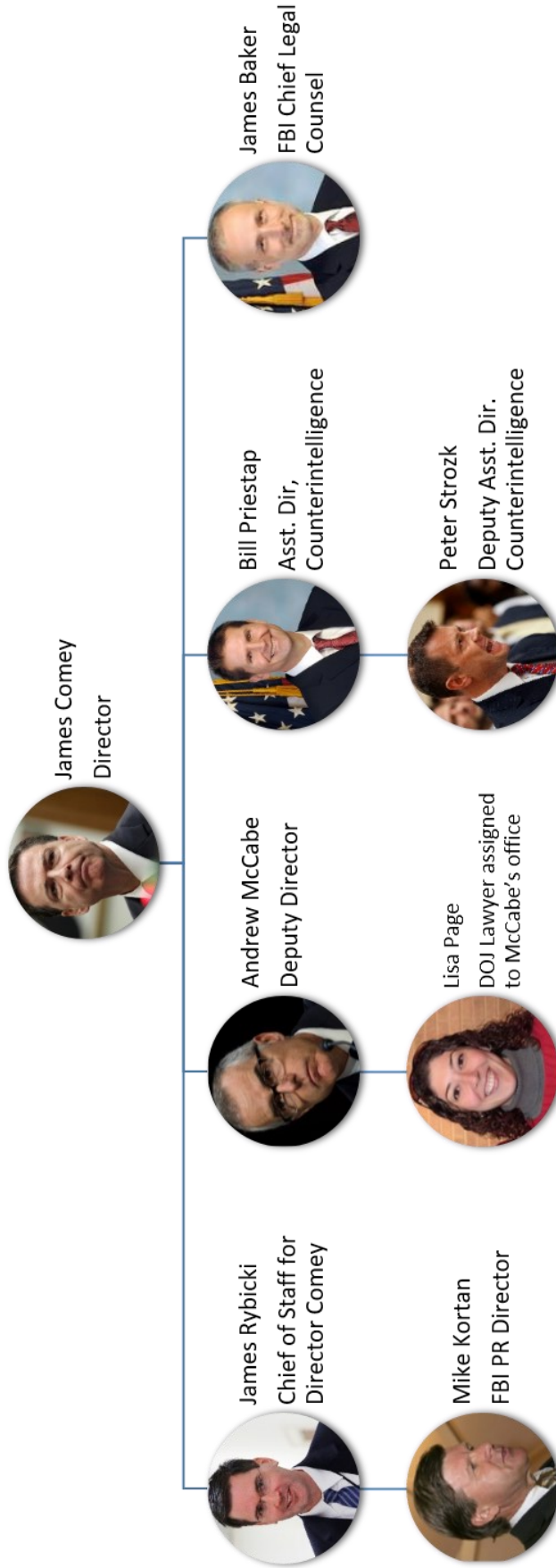


Obama FBI officials tied to surveillance in declassified intel



The stories behind the names...

In order of appearance on the organizational charts

Barack Obama, former President

Aware of the details of the Flynn intercepts, [chief to administration](#) rife with surveillance of the incoming administration, but [keeps it hidden](#)

Joe Biden, former Vice President **CONFIRMED UNMASKER**

Aware of the details of the Flynn intercepts; attended Oval Office meeting discussing Flynn surveillance; [conducted unmasking](#) in the Flynn surveillance operation.

James Comey, former FBI Director **CONFIRMED UNMASKER**

Signed [three FISA applications](#) to spy on Carter Page, a Trump campaign volunteer; part of the General Flynn perjury trap plan; leaked classified memos to [reporter Daniel Richman](#), oversaw a department full of corrupt activities

John Brennan, retired Director of the CIA **CONFIRMED UNMASKER**

The master controller of the Russia narrative, [using off-the-books resources](#) for intelligence and establishing a multi-agency task force to create the collusion narrative.

James Clapper, former Director of National Intelligence **CONFIRMED UNMASKER**

Partner in crime with John Brennan, pushing the Russian collusion charges, working with Brennan to create the [Intelligence community assessment](#) that furthered their Trump-Russia assertions

Loretta Lynch, former Attorney General

Met with Bill Clinton on the tarmac in Phoenix just prior to the exoneration of Hillary Clinton; Lynch was aware that Comey would not recommend criminal charges for Clinton before her announcement; also presided over the DOJ when the [falsified FISA applications](#) were made

Hillary Clinton, Secretary of State and Presidential candidate

Created the plan to employ Fusion GPS, financed through the DNC the [fake dossier](#), and was the driving force behind the Russian collusion story as the safety strategy in her presidential campaign

Samantha Power, U.S. Ambassador to the UN **CONFIRMED UNMASKER**

[Requested](#) unmasking identities over 260 times as citizens were being surveilled over the course of the election

Susan Rice, former National Security Advisor

The ["unmasker"](#) of the raw intelligence gathered on the incoming Trump administration, requesting the identities of those Trump officials that were being surveilled to be unmasked, or revealed; also present at the Oval Office meeting with Obama on the Flynn intercepts

Ben Rhodes, Deputy National Security Advisor for strategic communications

Scrutinized for his role in [unmasking](#) Trump campaign officials; questioned by the House Intel Committee

Denis McDonough, White House Chief of Staff **CONFIRMED UNMASKER**

Part of the Oval Office staff who was briefed on the findings in the surveillance, and discovered [Strozk texts](#) suggest he was also part of the coordination

Andrew McCabe, former acting Attorney General

Signatory on the Carter Page FISA application; part of the [inner workings](#) of the surveillance on the Trump team; the framing of General Flynn and all aspects of the FBI's counterintelligence

Peter Stroz, former FBI agent

Lead agent on Trump-Russia "investigation" and was part of the team that pulled the trigger on [setting up General Flynn](#); worked hand in hand with McCabe; famous texts with Lisa Page revealed that he assured Page that they would not let Trump win

Bill Priestap, Assistant Director and head of counterintelligence of FBI

Officially responsible for the investigation into the Trump campaign; Priestap's [handwritten notes](#) found in the recent document reveal, show the plan for laying a perjury trap for Flynn

James Baker, former FBI Chief Legal Counsel

Worked closely with McCabe; recipient of intel and a thumb drive that reportedly contained evidence of Trump/Russian interference in the election; part of the "[insurance policy](#)" described by Stroz and Page in the uncovered texts

Lisa Page, DOJ attorney assigned to assist Deputy DBI Director McCabe

On loan to the FBI from the DOJ; part of the small group that was running the day to day counterintelligence against the Trump campaign and administration; a [go-between](#) bridging Loretta Lynch and Sally Yates of the DOJ with James Comey and Andrew McCabe of the FBI in the operation

James Rybicki, James Comey's Chief of Staff

Chief of Staff to James Comey; part of the process of [exonerating Hillary Clinton](#) before the election; privy to much wrongdoing in his position

Michael Kortan, FBI PR Director

Coordinated with Lisa Page to [carry out McCabe's leaks](#) to reporters

Sally Yates, former acting Attorney General,

Part of the team that approved the FISA applications; signed one of the requests for Carter Page [skirting regular protocol](#)

Bruce Ohr, Associate Deputy Attorney General

Met with [former FBI informant Christopher Steele](#) multiple times; the go-between for the FBI and Fusion GPS; Steele fabricated the Trump dossier at the request of Fusion GPS, where Ohr's wife was employed; [delivered](#) the thumb drive that held the Steele dossier

Dana Boente, Acting Deputy Attorney General

Signed at least one of the FISA applications for Carter Page; part of communication with Stroz as [text records](#) indicate

Mary McCord, acting Assistant Attorney General

Participated in the meetings that Yates conducted on the [case of Michael Flynn](#)

Pray that God would move in the hearts of those who are being outed for their wrongdoing—may God capture their hearts! Pray John 10:10 that they would be set free from darkness.

Rod Rosenstein, Deputy Attorney General

Offered to secretly record President Trump in the White House by [wearing a wire](#), in attempts to gather information to [invoke the 25th Amendment](#), to remove Trump for being unfit

Robert Mueller, Special Counsel

Spent nearly two years on an [investigation](#) into President Trump's alleged Russian collusion; decided to [charge several peripheral players](#) on Trump's team—most of which were process crimes and, in one case, a blatant perjury trap; refused to proclaim Trump was exonerated after finding nothing on him

Andrew Weissmann, Member of Special Counsel

An attorney with a reputation for ruthlessness; part of the team that dangled an [investigation](#) into Flynn's son as a strong-arm tactic to push General Flynn to [plead guilty](#)

Brandon Van Grack, Member of Special Counsel

Partnered with Attorney Weissmann and other Special Counsel members to bring charges against [Flynn](#) and others

John Podesta, Chairman of the Clinton Campaign

Helped promote the Russia collusion narrative to benefit Clinton

Robby Mook, Clinton Campaign Manager

One of the first to promote the narrative that Russia was illegally helping Trump in the election

Donna Brazile, DNC Chairwoman, interim

Part of the Clinton presidential campaign; obtained debate questions in advance from CNN and [shared with candidate Clinton](#); promoted the Russian election collusion narrative

Glenn Simpson and Peter Fritsch, co-founders of Fusion GPS

Hired by the Clinton campaign through law firm Perkins Coie; their [opposition](#) research would produce the fabricated dossier on Trump

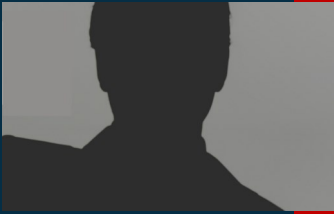
Nellie Ohr, Fusion GPS

Conducted "opposition research" for Fusion GPS; handed over a [digital drive full of information](#) paid for by the Clinton campaign to husband Bruce Ohr who worked in the Department of Justice; information she provided was hidden from the FISC, became the basis for FISA applications

Mary Jacoby, Fusion GPS

Wife of Fusion GPS co-founder [Glenn Simpson](#); visited the White House as a go-between
