Mail-in voting is just one avenue where evidence of potential fraud has surfaced. Online voting systems potentially allowed large-scale vote tampering. Right now, in six key states, multiple investigations are being conducted into online election fraud. How does the fraud work? By "breaking the set algorithms" for counting votes: A programmer codes an *automatic* upload of additional votes when a vote count for their desired candidate falls below a certain percentage lead. There is mounting evidence that this type of broken algorithm may have been used. It may explain the surge in Biden votes in the middle of the night when counting supposedly had halted in several states.

Attorney Sydney Powell's son, Wilson Powell, is a hedge fund trader that uses algorithms regularly--it was his job to create algorithms that would not "break." In his professional experience, Powell suspects that the [Dominion Voting Systems](#) programs used a broken algorithm to automatically shift votes to Biden, as evidenced by massive and strange vote dumps in Georgia, Pennsylvania, Arizona, Nevada, Wisconsin, and Michigan.
